#### <u>HISTORIC DISTRICTS TAX INCREMENTS – ECONOMIC DEVELOPMENT</u>

- There were comments made about the Historic Districts and Economic Development
- Washington County School District has a line item for historical money that comes out of the School District or the County?
- Washington County RAP tax is on the ballot this fall
- Santa Clara has a Historic District Tax the money accumulates Tax Increment financing?
- Tax increment money can be used How Tax Investment Financing Works
  Redevelopment projects in which RDA is involved are financed through a combination of
  public and private investment. A unique mechanism called Tax Increment Financing
  (TIF) enables the RDA to use the net new tax revenues generated by the redevelopment
  to help refinance the project.

Here is how TIF works. When a redevelopment project is being planned, the RDA analyzes how much additional real and personal property taxes should be generated once it is completed. That tax increment then can be used by the RDA either to finance the issuance of bonds or to reimburse developers for a portion of their project financing. In either case, the new tax revenue that is created must be used for improvements that have a public benefit and that can support the redevelopment effort, such as site clearance, streets, utilities, parks, the removal of hazardous materials or conditions, or site acquisition and the removal of blighted buildings.

TIF is used only when an area or property can't be redeveloped without public investment and when it meets a public objective, and then only to fill a gap between the total project cost and the level of private financing the project can support. In the case of developer reimbursement, the amount of money reimbursed depends on the success of the project, with the developer getting the money only if the project creates the extra value for the city.

All the additional taxes created by the redevelopment revert to the normal taxing entities once the RDA has fulfilled its monetary obligations related to a project. Thus, the neighborhood benefits from the creation of revitalized, productive properties and the taxing entities get new, permanent sources of revenue that wouldn't have existed if the RDA had not enabled the project to be undertaken.

- Municipalities have funding for preservation of historic places if they qualify as Certified Local Government (CLG)
- 1956 President Eisenhower signed into law the National Interstate and Defense Highway Act to facilitate an efficient way for the military troops to depart if under attack it established the interstate highway system. Due to this construction many historic properties were destroyed.
- Senate Bill 3035/Public Law 89-665, the National Historic Preservation Act was signed into law in 1966. The Legislation intended to preserve historical and archaeological sites in the United States. The act created the National Register of Historic Places, the list of National Historic Landmarks and the State Historic Preservation Offices.
